As we continue to advance the goals outlined in our Strategic Plan, we are actively building new and renewed partnerships with community organizations in Oxford County. These collaborations are not only enhancing our profile but also empowering the women and children who rely on the services of Domestic Abuse Services Oxford. A significant achievement this year, thanks to the collective efforts of DASO and Ingamo staff, was the declaration of Gender-Based Violence as an epidemic in the City of Woodstock and throughout Oxford County.

#### **Board Initiatives**

Last year, the board completed an update to governance policies and procedures for the agency, enhancing the ability to achieve our vision, mission and strategic objectives. Later in the year, a small task team was established to update the Board Orientation Binder. We aim to clarify the language and include new documents and training opportunities for incoming board members. This will ensure all members have a clear understanding of their roles, responsibilities, and expectations.

#### **Celebrating 50 Years**

2024 marks DASO's 50th anniversary, and it's an exciting time for all involved. In March, Soupstock, a former fundraising initiative was revived. This was a huge success, with many attendees expressing hope that it will become an annual tradition. Special thanks to Megan Porter, former Fundraising and Communications Coordinator for organizing the re-boot of Soupstock.Megan turned over the baton to Sophie Foster who will be arranging the details of a summer Open House plus organizing other events to mark this special anniversary.

#### **Gratitude and Farewells**

I extend heartfelt thanks to all Board members for their support and hard work over the past year. In June, we bid farewell to Sue Hodgins, who has completed her term on the Board. ## MESSAGE FROM THE EXECUTIVE DIRECTOR

In 2024, we honor 50 years of dedicated service to women and children in Oxford County. Our journey began in 1974, when Lee Lakeman took the courageous step of bringing abused women into her home on Hatch Street, unknowingly laying the foundation for the shelter system in Oxford County. Lee, working unpaid as a Coordinator alongside a collective of women at the Young Women's Christian Association (YWCA), became a pivotal figure in this movement. In February 1975, the center was officially named Women's Emergency Centre (Woodstock) Inc. (WEC). Despite the lack of government funding, Lee Lakeman, Julie Buell, and Janet Feeney tirelessly sought donations and grants to keep the center operational. Their courage and commitment established a legacy of support for survivors of intimate partner violence.

In June 1976, with funding from the Canada Mortgage and Housing Corporation (CMHC), WEC acquired a 10bed home, continuing to support families facing abuse. That year, 200 women and children found refuge at Lawrason Street. Financial challenges were a constant struggle; an article in the Globe and Mail highlighted that WEC often had to choose between food and heating bills. Undeterred, the WEC team remained committed to challenging attitudes that perpetuate gender-based violence, playing a crucial role in providing direct support and advocacy for women in Oxford County.

By June 1985, WEC moved to 117 Wilson Street, thanks to another CMHC grant and support from the Ministry of Community and Social Services (MCSS). This new facility featured a playroom for children, a lounge, offices, five bedrooms, and four bathrooms, offering three times the space of the previous location. Executive Director Louise Todd emphasized the importance of visibility and accessibility, asserting, "Women have been hiding long enough." With enhanced security features, she believed it was crucial for the center to be easily located by those in need.

In October 1991, our current location at 975 James Street was purchased with funds from the Ministry of Housing, ensuring enhanced accessibility for women and children. The new space provided increased security, privacy, and room to serve our community better. However, government funding challenges persisted, with budgets slashed by 21.6%. Under the leadership of Executive Director Brenda Boswell, the agency navigated these difficulties through community grants, generous donations and enhanced community relationships.

In 2011, Executive Director Rhonda Hendel rebranded the center as Domestic Abuse Services Oxford (DASO). Under this new name, DASO expanded its scope to address gender-based violence more comprehensively. The "Believe in Me" program was introduced to help women and their children/youth cope with the effects of witnessing or experiencing domestic violence. Additionally, a sexual assault counseling program for women aged 16 and older was established, along with transitional support and court support programs.

In 2023, the County of Oxford and the City of Woodstock jointly declared intimate partner violence as an epidemic. This declaration aligns with the first recommendation from the Renfrew County Inquest findings, which were conducted after three women were tragically killed by their former intimate partner. By making this declaration, Oxford County became the 25th out of 94\* municipalities to take this step. Domestic Abuse Services Oxford (DASO) is actively collaborating with community partners to implement further recommendations from the inquest, aiming to enhance the community's response to intimate partner violence.

As we celebrate our 50th year, we reflect on the remarkable journey that has brought us here and the countless lives touched by our services. We remain steadfast in our commitment to supporting and empowering survivors of gender-based violence, continuing the legacy of courage and resilience that began half a century ago.



## **Programs and Services**

#### **Kitchen Program**

The Kitchen Program has seen significant evolution since its inception four years ago. This year, the program has leveraged both minor adjustments and major upgrades through grants like Women's Shelters Canada and United Way-Oxford to create a positive impact on the 51 women and 40 children who sought shelter services. While consistently delivering delicious and nutritious meals, school lunches and snacks, the past year has seen a broader focus on nourishing the body, mind, and soul, and fostering a sense of community through food. DASO welcomed a new Kitchen Supervisor and a registered Red Seal Apprentice to transition from a single-staffed to a teammanaged kitchen. This opened doors to greater possibilities like emphasis on healthier food choices, showcasing affordable ingredients, teaching basic cooking techniques and engagement with Service Users to promote food literacy. As well as providing snacks and meals for group programs like Supportive Sweets, PEACE Program, and Community Support Groups.

#### **Community Support Program**

Over the last fiscal year, the Community Support Program delivered 1-on-1 brief support and psychoeducational groups to 81 women, focusing on coping skills, boundaries, and trauma education. By liaising with organizations such as Victim Witness, CAS, and CMHATV, the program ensured comprehensive system navigation and advocacy. Regular attendance at the Situation Table and operations out of Tillsonburg Livingston Centre every Monday enhanced accessibility and responsiveness. Targeted inclusive support for outreach women, public education and training upon request, and furthered connections with community partners have expanded the Community Support Worker's impact, making a difference in the lives of many women in the community. The CSW has also supported the agency around other initiatives such as the 50th anniversary campaign, creating promotional materials, and supporting in a temporary on-call capacity.

## **Programs and Services**

#### 24/7 Crisis Line

The 24/7 crisis/help line is available to individuals in Oxford County who are in crisis or who need help, support and information about any issue involving gender-based violence. It is also open to anyone in the community who has questions about abuse or is concerned about a friend, family member, neighbour or co-worker.

#### **Residential Program (Shelter Services)**

The Residential program is safe, secure accommodation for women identifying as women (with or without children) who are impacted by gender-based violence. Our 17-bed shelter is open 24 hours a day, 7 days a week, 365 days a year. Service users receive individual support, safety planning, information, and referrals as well as assistance customized to needs.

#### **Transitional Resource Program**

The transitional resource program helps women affected by abuse to overcome barriers as they start new, violence-free lives by providing advocacy, goals planning, safety planning, court support and assistance with housing. In the past fiscal year, the Transitional Resource Worker has been carrying an increasingly complex caseload due to lack of legal representation and lack of lawyers accepting Legal Aid Ontario cases in Oxford County and beyond. Like many other outreach services, the Transitional Program is seeing an influx of referrals, specifically for legal supports.

#### **Family Court Support Program**

Court support services are offered collaboratively by DASO, Ingamo Homes, Family Violence Counselling Program and Victim Services of Oxford County. Court Support staff at DASO work with existing services for victims of domestic violence to ensure clients have access to the supports they need at every stage of the family court process. This service will facilitate the client's understanding and navigation of the family court system.

## **Programs and Services**


#### **Intake Coordinator**

Over the past fiscal year, the Intake Coordinator (IC) program supported 178 service users by assessing their goals and connecting them to appropriate internal and external supports. The IC program provides risk assessment and management, safety planning, support with housing applications, brief legal system information and navigation, as well as referrals to financial, employment and counselling supports. The IC program ensures timely support amid an increased demand for outreach services at DASO. The IC program provides inservices to community partners regarding intimate partner violence and DASO services. The IC represents DASO for Oxford County's By-Name List and is the primary contact for all Special Priority requests for Rent-Gearedto-Income housing. The IC acts as DASO's second representative for Oxford County's Situation Table.

#### Family Support Program

The Family Support Program provides support for mothers and their children to aid in the transition from domestic violence to safety. The Family Support Worker also provides children's activities, respite, and advocacy with community partners. Together with Ingamo Homes, DASO implemented the PEACE (Prevention, Education, Advocacy, Counselling and Empowerment ) Program providing education and supportive counselling for children and youth that have been exposed to and/or witnessed domestic violence/abuse. The Family Support Worker and facilitators successfully ran two sessions in the fall and winter of 2023. The team continues to look at creative ways to offer the content.


